Retirement information is also available at the **Department of Retirement Systems** website, <u>drs.wa.gov</u>. This is a reminder that you can retire at age 62 with full benefits if you have worked for 30 years or more and use the 2008 Early Retirement Factors schedule (2008 ERF), but you must plan out your health care coverage until you reach Medicare age.

Washington State School Retirees' Association Legislative Priorities – 2025

Restore an ongoing cost-of-living adjustment for TRS 1 & PERS 1 retirees.

- Lost benefits: 50,730 retired teachers, school employees, and public employees have been without an ongoing COLA since 2011, when the legislature eliminated their annual benefit increase. Since then, most pensions have lost at least 25% of their purchasing power.
- **Restore fairness**: Only TRS 1 & PERS 1 members don't receive automatic annual COLAs.
- Seniors in need: Washington is among the most expensive states for retirees. Without an ongoing COLA, retired public servants are being forced to consider moving out of state to afford housing, food, and health care.

Paths to an ongoing COLA

Additional Priorities

- Maintain the \$183 monthly Medicare benefit for insurance plans offered through the Public Employees Benefits Board (budget line item).
- Cover mobile dental care through the Public Employees Benefits Board so retirees in long-term care settings can stay healthy (bill number forthcoming).
- Protect surviving family members from clawbacks by ending month-of-death pension prorating (SB 5114).
- Fully fund all pension plans.

GRANTS AVAILABLE FOR OCSRA MEMBERS

ATTENTION: <u>Members</u> of Okanogan County School Retirees' Association (OCSRA) currently employed or volunteering in one of the Association's school districts—

OCSRA offers <u>members</u> eight \$300 grants this school year. The grant must be used in a single school year to fund projects and materials (excluding field trips) not covered by other financial means. The grants must be used in an OCSRA School District and the application must have the signature of the *building principal*. This year four grants will be awarded in the fall with an October 15 deadline and four grants will be awarded in the spring with a February 15 deadline.

LEGISLATIVE NEWS

Dear WSSRA Unit Presidents, Legislative Committee Members, and Unit Legislative Committee Chairs,

The 2025 Legislative Session is off with a bang. Legislators are being forced to address a budget shortfall of somewhere between \$12 and \$16 billion dollars over the next four years. Budget cuts and new taxes are both being seriously considered as ways to help close the gap.

The shortfall is bad news for retired school employees, who rely on pensions and health insurance benefits funded by the state. In past budget shortfalls, we've seen legislators make cuts to pensions and benefits to balance the budget. For example, in 2011, the legislature eliminated the annual COLA relied upon by TRS 1 and PERS 1 retirees and substantially reduced the benefit provided to keep PEBB health insurance premiums affordable. We are vigilantly watching to make sure this does not happen again. We are also looking for creative ways to advance our priorities in a challenging budget environment.

Here are some of the most important bills we're following:

House Bill 1292/Senate Bill 5113 would provide an ongoing cost-of-living adjustment to TRS 1 and PERS 1 retirees. It is the result of many years of hard work and is the ideal solution to restoring benefits. Unfortunately, it also has a price tag.

Like HB 1292/SB 5113, **SB 5085** would provide an ongoing COLA to TRS 1 and PERS 1 retirees. However, it would be funded by merging TRS 1, PERS 1, and LEOFF 1, a closed pension plan for retired police officers and firefighters, into a single retirement system. The ongoing COLA for TRS 1 and PERS 1 members would be funded by the \$2.9 billion surplus in LEOFF 1. This would save the state money and is our most realistic path to an ongoing COLA this session.

HB 1312/SB 5114 would stop the state from clawing back deceased retirees' final pension payments. It would end the practice of month-of-death pension prorating and allow survivors to keep their deceased loved one's entire final pension check.
