### MEADOW VIEWS by Kathy Reim

Joanne Jones has been editing and formatting our newsletter for seven or eight years now and her hard work and dedication are part of what keeps the view hopeful. It is always about the people.

For Joanne, teaching was always about the relationship with young people. Like many of us, her fondest memories are of kids who came with challenges and troubled pasts - like the young man some years ago from the Secret Harbor School who attended her classes at Anacortes High School. She watched the changes as he moved from a bad attitude and sitting apart in the class to her gradual acceptance and then that of his classmates. It turned out he had a special aptitude for accounting, and a few years later he graduated to go on to become an engineer. Joanne recalls the day she heard him say about her, "She is tough and makes you tow the mark. She is a good teacher." At graduation his mother brought Joanne a dozen red roses.

Joanne taught in the public schools for 21 years and was drawn to teaching because she enjoyed her business and language classes at Seattle University. The department head recognized that she was skilled in these classes and said, "You should be teaching this." She went on to finish her education at the University of Washington. After taking some time to raise her children, she earned a Masters degree at Western

Washington University and returned to teaching because she missed working with kids.

That love for young people - to be in their lives in a direct way - has resulted in her serving for 33 years on the Board of Directors for Youthnet. Youthnet provides caring and supportive educational and social services to youth and families and has been an essential resource in this area for youth at-risk.

Joanne has enjoyed helping Unit 21 of WSSRA stay connected to one another. She enjoys working on the newsletter because she values having it look nice and organizing it. We are grateful for her patience as we work to get accurate information to her before the dreaded deadlines.

Joanne also loves racquetball, lived in Germany for three years where she was able to travel throughout Europe, enjoys reading and belongs to an Italian Club in Bellingham. She is a devoted Husky fan, and she has written about 50 children's books that she hopes to publish. These stories sometimes gently demonstrate the value of kindness. That seems fitting from a woman who has done so much to make this a kinder world.
