As you enter Anacortes on Highway 20, keep to the right, turning on the R Avenue Exit. Continue on R Avenue, which becomes Q Avenue. Turn right on Seafarers Way. Go one block and turn right on R. The ESD parking lot is the 3<sup>rd</sup> driveway on the left.



# **Meeting and Program**

There will be a business meeting at 11:00 a.m. followed by the catered lunch. We will leave the ESD building at 1:15 and proceed to the W.T. Preston Snagboat Heritage Center for a 1:30 tour. We are hoping to have a docent for our group; but if not, we'll manage.

The Preston was the last sternwheeler to work in Puget Sound and is one of two snagboats remaining in the contiguous United States. Her crews removed navigational hazards from the bays and harbors of the Sound and its tributary rivers.

The W.T. Preston was placed on the National Register for Historic Places in 1979. In 1981 the Army Corps of Engineers retired her from duty and solicited proposals to preserve the snagboat. In 1983 the Corps transferred the title to Anacortes. The city allocated \$40,000 to prepare a waterfront site for the Preston beside its old Burlington Northern Railway Depot.

Please join us to see this important part of our Western Washington history.

Admission is \$3 for adults and \$2 for seniors.

## RESULTS OF THE SPECIAL LEGISLATIVE SESSION

Washington State has adopted a supplemental budget. The agreement took one Regular Legislative Session, two Special Legislative Sessions, and an additional seven hours. In the end, Legislators voted to reduce pension benefits for future employees, change the K-12 healthcare structure, and retain the \$150 Medicare Eligible Healthcare subsidy.

**2ESB 6378 - PENSION REDUCTIONS**. THIS BILL WILL ONLY AFFECT NEW SCHOOL AND STATE EMPLOYEES. THE BILL DOES NOT CHANGE BENEFITS FOR CURRENT RETIREES OR ACTIVE EMPLOYEES WITH AN ESTABLISHED MEMBERSHIP IN A STATE RETIREMENT PLAN.

### The Legislature will:

- 1. Keep TRS/PERS Plan 2, defined benefit pensions, open for new school employees.
- 2. Make the necessary \$146 million payment to the TRS/PERS unfunded liability.
- 3. Reduce early retirement benefits for future State and school employees. Anyone beginning school employment after May 1, 2013, will have the option of retiring at age 55 with 30 years' service. However, those employees will lose 5% of their monthly pension benefit every year before the age of 65. A future school employee could retire at age 65 with a full benefit, at age 60 with a 25% reduction, or at age 55 with a 50% reduction.
- 4. The Select Committee on Pension Policy, Washington State Department of Labor and Industries, will study risk classifications for state and school employees. They will make recommendations to the Legislature for additional Early Retirement Factors in certain strenuous school and public employment positions.

### SUBSTITUTE SENATE BILL 5940 - K-12 HEALTHCARE BENEFITS

The legislature attempted to reduce K-12 healthcare expenses through ESSB 5940. This legislation is significantly altered from its original version and does not affect retirees.

- 1. School districts will be required to provide health plans with a wide range of premium options.
- 2. Family premiums will be required to be less than 3X the cost for individual coverage. Individual premiums will subsidize dependent premiums.
- 3. K-12 health plan data will be submitted to the Office of the Insurance Commissioner for analysis and review.
- 4. The Office of the Insurance Commissioner and the Washington State Health Care Authority will review insurance data and make policy recommendations to the Legislature by 2016.

Please read the above carefully and contact your legislators about your feelings concerning the decisions made.

#### WHY SAVANNAH?

Kathy Reim was born in Savannah, Georgia, right at the end of World War II to a mom who was raised in North Carolina. Kathy spent her early childhood traveling with the circus across the mid-west and southern part of the country and then at 8 years of age found herself part of a new family in a small town in Texas. She remembers that when she graduated with the class of 1963, she was still the new girl.

After being selected for a tuition scholarship by her teachers, she went off to North Texas State College (now the University of North Texas) in Denton, Texas, under the newly established National Defense Education Act.

"We are framed by our stories," Kathy says. "I was drawn to teaching because I had such good teachers in my life. I was drawn to the students who came with unconventional stories and atypical lives. I am dedicated to maintaining an American Dream that is within reach of every child because it was available to me."

All of that is not unusual for teachers. What, however, creates school employees who are also eager to work on behalf of the wider issues in education? Well, stories are also certainly part of that.

"It helped that I was non-renewed, riffed, early in my career," she says. "It still makes me laugh that we find euphemisms for being laid off or fired. I came from a working class background so I knew being fired wasn't always personal. I also knew that being organized and having a union was important.

Kathy continues, "I went to that first meeting after getting the nonrenewal notice and remarked to one of my "riffed" colleagues, 'So they fired the tall lady over there with the silver hair, too?""

"Oh, no," he replied. "That is Vi Sexton, and she is here to help."

"She was and still is." Kathy says."

"As we get together at meetings and for conversation, the stories are important. Our younger colleagues are learning from their stories. Every generation thinks is it smarter than the one before and wiser than the one coming after; but we do have wisdom to share. Togetheracross generations- we can work in the best interest of public education and support the hardworking people who over time and especially now, develop hope for the future."

"Oh," she added, "and that is why my Yorkie's name is Savannah."
