Please let me introduce the new president of WSSRA Unit 21 to you - -Mr. Bruce Boyer.

Bruce comes to WSSRA with a 47 year history in the educational field. He graduated from Western Washington State College in 1970 with a BA in Science Education. He then became a science teacher, mostly chemistry, at Mount Vernon High School, Mount Vernon, WA. He stayed in that position until 1997.

In 1997 Bruce became the Assistant Principal for Lynden High School, Lynden, Washington. During the time Bruce was working in Lynden he also obtained his Masters Degree from Western Washington University (1980). He tells us that he loved the small town atmosphere and community connection he found in the Lynden populace. Having worked in Lynden as a school administrator at the same time Bruce was there I can only agree with his opinions on this. Bruce was very effective and student oriented in his approach to his job.

Mukilteo School District lured Bruce away in 2000 for a four year stint as school administrator for their district. For the four years Bruce was an administrator at Mukilteo's Mariner High School, he enjoyed the various cultures and the 43 different home languages found in their school environment.

In 2004 Bruce became a liaison for two different universities and worked with student teachers in the classroom. He really liked being back in the classroom and continued in this phase of his career for 16 years.

All during this time Bruce had a dual career. He raises beef cattle—and has since the early 1970's. He shares with us "that all through the years of teaching, putting up hay from the fields was one time of the year that I could start something and see it through to completion in a short period of time. During my time in teaching, it felt more like I was on a walking machine with a belt just trying to keep up with all the incoming issues during the school year."

Bruce tells us that farming has been a great way to get in exercise on a regular basis without going to a gym and much easier to "schedule" and stick with. Bruce and his wife of fifty years this month, Pat, have two children who grew up helping with the haying during their summers and now two of their grandchildren have been helping. The farm currently puts up more hay now than in the past and though it is more work, it is not the adventure that it was in earlier years.

Bruce joined Unit 21's Board in 2015 and was elected to the President's position for the 2017-2018 term. He finds working with this group of retired employees has been a good outlet and way for him to meet people with similar experiences and values. Anyone looking to join in any of our board or unit activities may contact any of our board members and work in whatever/whenever way you would like. The more the merrier.

Bruce is looking forward to working with the board this year in a new position with support from the rest of the group. We will have at least one activity for all of us to be able to attend. This event, to be finalized later this year, will be posted in our newsletter. This will give you all the opportunity to get the needed information to help you during retirement and also to give you a chance to reacquaint yourself with colleagues of your past."

Today, thanks to an article by Dr. Robert Ashley and published in the Skagit Valley Herald, we will pass on some advice on pain relievers. Pain relievers should be taken infrequently but many people tend to take them too often. The following information is to help you make the decision on which pain reliever to take and how often.

*Tylenol has been used since 1955. Doses over 4,000 milligrams per day can cause liver damage, even death, if you are using alcohol during the same time.

*<u>Ibuprofen</u> has been used for pain relief since 1974. This medicine has been classified as a non-steroidal, anti-inflammatory drug.

*Aleve was marketed in 1976 and it works similarly to Ibuprofen. It has a long shelf life and gives longer lasting relief.

Both Aleve and Ibuprofen affects chemicals produced by the body and can work against the natural hormone-like substances that naturally protect the stomach lining from acidity. Extended use can cause stomach inflammation, ulcers and, possibly, severe bleeding.

*<u>Celebrex</u> can lead to kidney injury for those older individuals who have congestive heart failure or cirrhosis.

All the medications listed above are good treatments if used for short spans of time and one avoids their use for extended periods of time, especially if one has a history of heart disease,

*Acetaminophen is the safest when used regularly at doses no higher than 4,000 milligrams per day. If Acetaminophen is used regularly cut the daily dose to 2000 milligrams per day.
