**Health:** Influenza Virus – The influenza virus not only attacks children but the elderly as well. The flu season is here and a huge problem. Many have died across our nation due to the extreme contagiousness of this virus. This respiratory illness spreads quickly through our population.

Symptoms to be aware of may include fever, chills, sore throat, cough, a congestion of the lungs, sinus problems, head and muscle aches and even diarrhea and/or vomiting. Older adults are at a greater risk as after age 65 our immune systems are not as robust and can't fight off infections as efficiently as they once could. More serious conditions such as myocarditis (inflammation of the heart) and inflammation of the brain can occur. In extreme cases our body's inflammatory response to flu infections can lead to sepsis, a life threatening condition that requires immediate treatment.

It is very important that we all get a flu shot in the fall to help control this disease as well as build our immunity to

## **Committee reports continued**

Legislative: Your WSSRA legislative Committee descended on Olympia the week of January 22 through 24, from all across the state with every unit being represented. We met at the Governor Hotel in Olympia for training in Advocacy and Lobbying activities. Peter Diedrick (Legislative Director), Dr. Alan Burke (Executive Director), Dr. Curtis Horne (WSSRA President), Ester Wilfong and Larry Scholl, (WSSRA Legislative Committee CO-Chairts) gave each of us pointers plus information on the current legislation on our pension issues. Our lobbyists, Fred Yancy an Michael Moran, informed our committee about the current bills offered that impact our pension benefits.

Skagit, Island, San Juan Unit 21 has three members on the Legislative Committee, Diane Visten, Barbara Robinson, and Bruce Boyer. For the January 2018 visit Bruce Boyer and Barbara Robinson partnered with Tim Knopf and WSSRA President Elect, Linda Averill, and used a team approach to visit the legislators from Districts 1, 10, 21, 32, 38, 39, 40, 42, and 44.

The team came out of the visits feeling hopeful about the chances of a COLA and some support on our Retiree Medical Benefit. Many legislators professed to support our needs and to recognize that WSSRA members had earned these benefits. Some legislators were willing to go the extra mile and to keep our bills moving. Some have signed onto those bills.. However there are some who say "no money" and are not willing to make that change in their thinking. Hopefully when the legislators receive a report in Mid-February on the sate of our economy and the earning generated there will be movement.

Your WSSRA committee is saying that "there is money, we have earned it and if not now then when?" Your WSSRA team has been "visiting" Olympia on these matters for several years but this feels like the time we are closest to having something positive come out of the legislative process in regard to our needed benefits. We need to make a difference this year, but it will take your help. Several of you sent "stories" about how the lack of COLA and the decrease in our medical subsidy have affected you and your family. Several legislators mentioned that they are more likely to help when they hear directly from their constituents about specific issues. It is obvious that we need to keep pressure on them to keep these bills alive and moving through the required committees and legislative process

This is where we all can make a contribution. We need for you to continue to phone or send personal letters or emails until we are successful this legislative term. A point to remember: if your pension is for \$25,000 per year, you have lost \$6000 since 2011 plus a loss of \$33 per month for your medical benefit. This correlates to over a 12% loss in purchasing power while your daily living expenses have continues to go up.

## Here are the bills we need to "speak" to:

 House Bill 2452 and Senate Bill 6305—provide a 3% increase to all TRS 1 and PERS 1 retirees on the first \$25,000. In addition the bills increaser the Retiree Medical Benefit to at least 50% of the insurance premium.

# Here are the legislators that you need to "speak" to:

- District 39: Senator Keith Wagoner, , Representative Dan Kristiansen, Representative Carolyn Eslick
- District 40: Senator Kevin Ranker, Representative Kristine Lytton, Representative Jeff Morris

Don't let your Legislative Team work be wasted by not backing them up. Don't let this opportunity to increase <u>your</u> retirement benefits lapse because <u>you</u> did not let your legislators know what <u>you</u> need and what <u>yo</u>u want. This is urgent and requires immediate action on your part. This is the closest we have come to getting back our COLA. You need to contact your Legislators to vote this out of committee. <u>Your</u> letter, email or phone call counts.
