President's Message

Unit 21 has had a busy summer and fall. After 5 of us attended the successful WSSRA June Convention, we have done the following:

1. Prior to our summer retreat, our finances were audited and found to be in excellent shape. The only suggestions were to put the checking and savings account numbers; our Annual Report to the Secretary of the State; our 501 c)4 and Federal ID status into both the President's book as well as the Treasurer's book.

2. We held our August Retreat at the Burlington Police Station and after finalizing our budget for this fiscal year we prioritized our action plan for the year.

3. Sponsored, with the League of Women Voters, a community forum featuring two of our local legislators (Representatives Dave Paul and Norma Smith from the 40th District). They talked about how they found some issues to work on together in Olympia, with hopefully more collaboration in the future.

4. Co-hosted, with the League of Women Voters, a community forum on the impact of homeless students in our local schools. Several District representatives were present to share how this issue is affecting them and how they are dealing with it. This event had over 100 people attend and we thank those of our members who decided to join us. The more people that attend such events, the more the community and legislators see us as "active" and "community oriented", both of which will help us as we work with legislators during the year. Also, if you are doing any volunteer work please let me know because WSSRA is going to use the number of volunteer hours done by our members when we push for a COLA and other fiscal issues this coming legislative session

5. Attended a benefits fair held at La Conner School District to introduce WSSRA to their members. We were able to add three new active (currently working) members at that time.

6. Created and distributed goodie bags for all La Conner School District personnel. These bags contained a pencil with our email address, a small note pad with our logo and address and some treats to help with their energy level. We also held a drawing from new enrollees at each location for one of our mini grants.

7. Revised our mini-grant application form and have sent out the introductory letter and grant application form to all regional school superintendents. If you know of someone who is currently working in one of our local school districts, be sure to remind them to apply. Last year we gave out 25 grants for \$150 each and are doing so again this year. Applications may be turned in from Oct. 7-21.

Elsewhere in this fall newsletter, you will find articles on some of the above items and our upcoming Holiday Luncheon, our award winning Membership Chair Barbara Robinson, and other pertinent information.

WSSRA Legislative Committee Update

At our last state membership meeting we were given the new legislative goals for the upcoming session starting in January 2020. They are:

2020 Legislative Agenda for Plan 1 Members:

- Institute a permanent TRS1/PERS 1 COLA
- Increase the PEBB Medicare Subsidy
- Support the State Actuary's plan to eliminate the unfunded liability for TRS and PERS Plan 1
- Reopen the PEBB enrollment window for employees who missed the original 60-day deadline
- Eliminate the cap on substitute teaching

2020 Legislative Agenda for Plan 2/3 Members:

- Maintain the 3% COLA
- Reduce the early retirement factor (ERF) full retirement age to 60
- Increase the PEBB Medicare Subsidy
- Remove the 180-day cap on TRS VEBA benefits
- Allow September retirees to collect a COLA the following July
- Reopen the PEBB enrollment window for retirees who missed the original 60-day deadline

Homelessness: How it affects our Students and our Schools August 19, 2019

On August 19th, our Skagit, Island, San Juan School Retiree's Association co-sponsored with the League of Women Voters of Skagit County, an event on Homelessness and the Impact on our Students and our Schools. We began with our moderator giving us a briefing on homelessness in our county, providing a background to our subject.

Next Phil Brockman, Superintendent of the Sedro Woolley School District informed with an explanation of the McKinney Vento Act which is a mandate from the Federal Government that sets out guidelines and provides support to each school district when dealing with the issues of student homelessness. Representatives from Anacortes, Mount Vernon, Sedro Woolley and La Conner school districts then shared what is common across the schools and what is unique to each district. We heard stories of how this issue affects students. It makes learning a most difficult task for those students who are not always sure where they are going to sleep that night or where their next real meal will come from.

A panel of service providers next spoke of their programs and how they support homeless students and their families. Groups such as Anacortes Family Center, Community Action, Family Promise, and Friendship House told stories of how they are successful in supporting the families and how their programs continue to be needed.

This event was one of several as we learn about the homelessness issues our community faces. It was an eye opening event and it was also an inspiring event. There are many in need and there are many stepping up and making a difference. Since we, school retirees, have had some experience with student issues we felt this would be an important program to present. We had over 100 people attend, including community leaders plus some legislators. We feel the more we know the better the chance we can meet the needs. Our goal of informing was successful. We have seldom had this large an audience. We are hopeful that this discussion will lead to more people working on this issue. It is very important to those that are working in the schools and to those that are retired but still are concerned about our schools and our students.
