LEGISLATION OF INTEREST TO RETIREES:
COLA for Teachers: HB 1823. This
bill would give a small increase in
retirement checks to those who retired
before 1973. LOST in Ways and Means.
A slight chance to be attached as an
amendment to another bill.
The Senior Citizens Lobby supported
HB 1823.

HEALTH ISSUES:

The Lobby supports the following bills which are still alive.

HB 1462: Long-term Care Insurance Bill. Deals with the prohibiting of any hospital stay as a prerequisite for any benefit.

SB 4574: It treats all recipients of chore service equally in the event of cuts.

HB 1391: Exempts the tax on Hearing Aids.

SHB: 131: This bill would increase the college education requirement for nursing home administrators to 4 years. The Lobby supports that the degree include health and business courses.

HB 1332: a revision to the Generic Drug Law allows individuals to request brand name drugs if they wish.

SB 4896: Licensing of home helath agencies. This is a way to assure quality care.
