

Thurston County School Retirees Association (TCSRA) Collection

Scope and Content

The records of the Thurston County School Retirees Association (1954-Present) covers the period after the group's reorganization in 1964 until the early 2000s. The collection contains minutes, membership directories (yearbooks), club history (notes and documents), the club's newsletter *Bits & Pieces*, and meeting programs. Some of the minutes notebooks are organized scrapbook-style with photographs and clippings throughout. Original minutes from the early meetings are not present, although there are typed copies of the minutes from 1959-1967. There is also a set of tabletop decorations that identify TCSRA members with a biographical sketch and a photo.

This is a growing collection and the TCSRA expects to make an annual contribution.

Historical Note

On September 18, 1954, a small group of women met at Olympia High School to organize an Olympia and Thurston County Chapter of the Retired Teachers' Association. The first president was Mabel Fox. The goals of the organization were:

- to promote the social and educational welfare of retired teachers,
- to keep alive their interest in education,
- to take an active part in civic affairs, and
- to make an organized effort to secure and maintain suitable homes for retired teachers.

The early meetings of the group were held on the third Saturday of each month, usually excluding the holidays and summer months, except for the occasional summer picnic. Their meeting locations varied and included Olympia High School, the Olympia Community Center, the Coach House of the State Capitol Museum, the Courthouse, restaurants and even members' homes when a public location could not be found.

The group grew and by 1956, there were 26 members reported. Early issues of concern included insurance, pension, legislation, health care and community service. These issues continue to be important today.

By the early 1960s, membership attendance had dwindled; only six to eight people were showing up for meetings and sometimes there were not even enough members to hold a meeting. Historian Ruby Dinglee attributed the decline to the loss of early leaders Mabel Foxwell (died in 1962) and Fannie Johnson (moved away in 1959) with no replacement leadership to follow them. The group considered joining forces with another unit in Tacoma or Centralia. The breaking point for the organization came in April 1964 when the nominating committee had no candidate for president for the next year.

Later that year, in October, a meeting to reorganize which included the Washington State Retired School Teachers' Association president, Mrs. Elsie Schartow, was held with 22 members present. The organization was reborn under a new name (*Olympia* was dropped), a new president (June Ramaker), a new constitution, and the institution of membership yearbooks. Meetings were held mostly at local restaurants on the 3rd Friday of the month.

Ruth Ball, a resident of Panorama City, introduced the idea of meeting at Panorama by hosting in her home in January 1965. By the end of that year, the minutes reflected 50 or more members attending each meeting. Men also began to join and take active part in the group. By 1967, there were 13 men out of 88 members (15%). Another turning point happened at the January 1966 meeting where it was announced that due to the group's population explosion, one luncheon would be served to all instead of individual meals. That meeting was also the first time the group met at the Panorama restaurant.

The first male president to run the organization was Herman Miller who served from 1967-1970. Under his leadership, Panorama's restaurant became the designated meeting place and it remains so as of this writing in 2018.

The first bulletin was printed during the 1977-1978 year under the leadership of president Bert Oliver. Myrtle Quick gave it the name *Bits & Pieces* in 1980-1981.

When the budget was made for the 1983-1984 fiscal year, the TCRTA board realized that their income would have to be supplemented. In addition to raising dues by \$2 per

person for the next year, many tactics for raising funds were implemented such as assessments, raffles, bargain table sales, automatic pension deductions and recruitment of new members.

On July 28, 1997 the TCRTA Endowment Fund was established through the Community Foundation to provide small grants to teachers in Thurston County to enhance learning in their classrooms.

After several failed attempts at the state level to change the "Teachers" in the organization's name to "Educator" to be more inclusive, the decision was finally made in June 2000 to change "Retired Teachers" to "School Retirees." TCRTA followed suit and changed their name to Thurston County School Retirees Association (TCSRA) on April 19, 2002.

By 2005, there were 623 members and it was one of the largest units in the state association. Over the years five members have become state presidents. Only the Seattle unit has provided more presidents from their organization.

As of 2018, the ranks of TCSRA have swollen to nearly 800 members and they serve all retired and active school employees. According to their website, they provide the following services:

- Protecting retirement security and benefits through lobbying for legislation
- Providing pre-retirement workshops
- Keeping members informed on health and consumer issues
- Awarding mini-grants to Thurston County elementary and secondary school employees
- Granting scholarships to graduating high school seniors (in cooperation with WSSRA and PEMCO Insurance Company)
- Helping with community efforts that benefit children, the elderly, and those in need
- Encouraging fellowship through monthly luncheon meetings at Panorama's restaurant in Lacey
- Publishing an annual directory and *Bits & Pieces*, a monthly newsletter, for our members

Provenance and Acquisition Information

This collection was donated by the Thurston County School Retirees Association through then-President Karen Keller. The first donation came on July 7, 2016 (accession number 2016-005) and included the Minutes & History notebooks, some membership directories, documents on the organization's history and a book on school names history.

The second donation was delivered again through past president Karen Keller on July, 24, 2018 (accession number 2018-015). It included more membership directories, newsletters, more history documents and notes, meeting programs and tabletop tents with member biographies. Two books created by schools to thank TCSRA for grant money were also included.

Processing Information

The material was found in a fairly organized manner and lent itself to easily divided series. The notebooks were kept exactly as they were given. It was decided to divide the series by items that were created by the organization and items that were created outside the organization. The notebooks do not fit comfortably inside a record carton with the lid on, so another container will need to be used so that they can be fully enclosed. Duplicates were discarded in most cases unless there was a compelling reason to keep both. Paperclips and rubber bands were discarded.

Booklets are arranged by year. Most booklets cover a school year (Sept-June), size and format varies. Some years are missing. Information within includes a list

of officers, committee chairs, dues rates and membership information for the local and state organizations, a list of each monthly program date and speakers, and a member roster with address and phone numbers. Some yearbooks also include the purpose and officers of the state and national organizations, quotations about education, state convention sites, a list of past presidents, contact information for useful offices, endowment fund donation information, the information for executive board meetings, or handwritten notes of the original owner.
