## PARADE OF PROJECTS

April is traditionally the month when we invite mini-grant recipients to a luncheon to share how they used their mini-grant funds. Last year we asked them to share on Zoom, either live during our meeting, through a power point presentation, or with a video. This year as we got closer to April, we realized that ***we could not ask recipients to do one more thing***. This has been another difficult year for our active members. Students returned to school this fall at different levels; substitute teachers, paraeducators, and bus drivers have been scarce; as COVID continued to spread, classes were disrupted. Our mini-grants are one way for us to support our active members. This year our committees will also support them by *not* asking them to leave the classroom where they are most needed, while we present summaries of some of their projects.

We had 32 elementary applicants and 17 secondary applicants from Olympia, Yelm, North Thurston, Rainier, Tenino, and Tumwater. This year we were able to give grants to all of them.

***Here is a look into some of the elementary projects:***

♥ One teacher asked for funds to order Burke Boxes from the Burke Museum in Seattle. These are wonderful assortments of artifacts and items grouped by theme.

♥ Wanting to pair musical concepts with literature, a music teacher purchased books with story songs, biographies of composers, and picture books that bring musical concepts alive for her youngest learners.

♥ A class set of journals and pens was needed for a class of 5th graders. "We have come across so many big emotions, high anxiety, and big feelings for this group of pre-teens."

♥ Flexible seating was a popular request. Stools, bounce chairs, and cushions boost overall

academic achievement by increasing student motivation, choice making, and overall engagement.

♥ Lacrosse is gaining popularity in the Olympia area, so a PE teacher used funds to buy 26 lacrosse sticks for her 3rd–5th grade classes.

♥ "Our third-grade team is implementing *First Chapter Friday*. Every Friday, each teacher will select a chapter book and will give a sneak-peek into the book. It's a fun, engaging way to encourage students to participate in independent reading."

♥ Several applicants were first-year teachers who needed supplies and books for students. This included notebooks, pencils, whiteboards, folders, and bins to help keep their supplies organized.

***Our secondary classroom needs were as diverse as the courses being taught. Here is a look into some of their requests:***



♥ Items needed for a "calming corner" included a saucer chair, a multi-function electronic timer, a pack of plastic storage bins, assorted fidget toys, pop it toys, a mindfulness game, a marble maze, a logic puzzle book, and a breathing board. *[If you don't know what some of these things are, you could look them up on Amazon.—Editor]*

♥ Funds for transportation and a one-day substitute

## **LEGISLATIVE REPORT**



Never tell a constituent that a bill is dead. That critical advice is drilled into all legislative staffers. It's stalled; yes, that's okay. It's a zombie bill; sure, it gets the point across. The reason is that on rare occasions the rules are suspended, and a bill gets resurrected.

One of our "dead" bills, HB 1699, was resurrected in the final moments of this legislative session. HB 1699 temporarily increases retiree return-to-work hours from 867 to 1040. School retirees will be able to substitute in classified and certificated positions—excluding central administrative positions—for an additional 21 days or 173 hours. The new law will be in effect through the year 2025.

Legislators passed a record-breaking operating budget, \$64 billion in sum. Much of that is one-time federal money. WSSRA's contract lobbyists think the biennial budget written next year will be closer to \$55 billion after the federal money is spent.

Fortunately, school retirees had some important items in the budget. The final budget included the \$183 monthly Medicare Eligible Healthcare Benefit. Legislators made the actuarially recommended pension payment to the pension funds.

Legislators also passed legislation for a Plan 1 COLA to take effect this summer. Plan 1 retirees will receive an increase of 3%, up to \$110 per month, starting this summer. Plan 2 and 3 retirees will receive a 3% increase as well, so all retirees who have been retired for more than a year will get a pension increase in July.

## **2022-2023 TCSRA BUDGET**

The TCSRA Board has approved a 2022-2023 budget to be submitted to the membership for a vote in May. Income projections for the new year are \$63,690, an increase over the projection of \$56,190 for this year. The main reason for the increase is that our carryover has grown due to the virtual rather than in-person convention and unit luncheons. The projected expenses for next year are \$41,022, a decrease of \$5,250 over this past year's expenses of \$46,272. The reason for the decrease is that mini-grant funding was returned to the usual amount after the one-time increase due to carryover funds in the current budget. Also of note is that TCSRA will now award three scholarships, including a donation to the Gene Forrester scholarship. were requested so that students could participate in an outdoor science inquiry program at the Mount Rainier Institute.

♥ New Market Skills Center requested funds to purchase an acrylic mirror to go above a work demonstration area in the Culinary Arts class so that students can see cooking demonstrations while staying seated.

♥ In order to restore a wooded area next to the school while creating a garden, one classroom requested gardening tools.

♥ The Veterinary Assistant program at New Market Skills Center has a small budget provided by the school but needed funds to purchase additional supplies such as bandage materials, lab materials, and PPE for surgery practice.

♥ There were numerous requests for novels for classrooms and for Battle of the Books.

Mini-grants make a difference for students and teachers, and Thurston County School Retirees' Association is pleased to provide the funding. Applications for mini-grants for the 2022–2023 school year will be available on our website on September 1.

## NOMINEE BIOGRAPHIES

### **Patty Gee, Secretary & Nominating Committee:**

After 20 years with North Thurston Public Schools, Patty went on sabbatical to earn her master’s degree at Central Washington University (CWU). Patty now has the time and desire to become the secretary of TCSRA, and she looks forward to reconnecting with her fellow teachers and support service colleagues.

**Sue Ballard, Nominating Committee:** Sue grew up in Olympia and attended Lincoln Elementary, Jefferson Junior High, and William Winlock Miller High

School—now Olympia High School. She earned a B.A. and an M.Ed. from Central Washington University, and she also taught at Central for several years. Sue started her K–12 career in the Olympia School District, where she taught Special Education and Child Development.
