PRESIDENT'S MESSAGE

TCSRA committees have had a busy spring. The work of the Nominating and Finance Committees appears elsewhere in the newsletter. The Communications Committee updated the Unit 28 rack card, originally designed by students at New Market Skills Center, and prepared and ordered business cards for board members.

This winter, the Bylaws Committee reviewed the 2018 TCSRA Bylaws. Periodically, bylaws must be updated to reflect organizational changes in practice and policy. Our bylaws also need to be reviewed for alignment with those of WSSRA. Units within WSSRA are independent, though affiliated, bodies. Therefore, our bylaws provide direction and protection as we do TCSRA business. Circumstances dictated by COVID—19 shaped many of our activities over the last three years. Some of those changes were so successful that they are now incorporated into the proposed amendments. Other changes clarify intent, correct language usage, remove redundancies, and, in a couple of instances, add articles on necessary topics such as non-discrimination and whistle-blower protections.

Here are examples of some proposed changes and the reasons for them. Our unit treasurer has not collected dues for years, although this was a past practice and remained in the bylaws. WSSRA receives our dues. The amendments make this correction. The amendments allow for electronic meetings, e.g., Zoom, and remote voting using email or USPS. Remote voting increases opportunities for all Unit 28 members to participate, rather than only attendees at a meeting. One over-arching concern has been to provide flexibility in an effort to accommodate future needs. For example, we could not fill the position of president-elect or vice president this past year. The amendments allow flexibility in an effort to fill some positions.

Voting on the proposed amended bylaws will occur in May; instructions for remote voting by email or USPS will be in the May *Bits & Pieces*. The deadline for voting is May 14. The proposed amendments to the current bylaws are posted on the TCSRA website. Paper copies will be mailed to members who request them.

It's A PARADE OF PROJECTS!

April 2023

TCSRA received 39 elementary and 16 middle/high school applications for mini-grants, several from TCSRA members. The applications described a variety of worthwhile projects, covering a wide array of areas. This year, we were able to fund all requests, for a total of \$13,061.

One applicant requested sports equipment for a program where classroom teachers teach skills such as problem solving, cooperation, and communication. Creating "Calming Corners" in Olympia classroom spaces was a grant winner. Students have real-time access to a space and materials to practice emotional skills and reduce class disruptions. After-school enrichment was a popular request. Art club for grades 3-5 in Tenino serves 15-30 different students per session. The Sphero Robot is an educational robot requested in Tumwater and Rochester for science enrichment. It is a great entry into robotics for beginners. Students learn coding and computational thinking. Many classes asked for books and headphones, and one class is building a school garden.

At our luncheon on Friday, April 21, we'll look at photos and hear from a few of these teachers. It's fun to learn what is happening in our schools. Bring a friend, and be sure to make reservations for your entire party. [See page 2 for reservation information]

2023-2024 TCSRA BUDGET

The TCSRA Executive Board has approved a 2023-2024 budget to be submitted to the membership. Income projections for the new year are \$72,731.00, an increase over the projection of \$63,690 for this year. The main reason for the increase is that our carryover has grown due to the decrease in activities during the years of COVID. The projected expenses for next year are \$72,731.00 with \$18,000 expected to be carried over to the 2024-2025 budget.

Mini-grant levels have returned to the pre-pandemic level with a 10% increase. Elementary mini-grant award fund will be \$7,700 and the secondary mini-grant award fund will be \$4,950.

TSCRA will continue to award three scholarships, including a donation to the Gene Forrester scholarship for seniors who plan to major in Agricultural Education at WSU.

LEGISLATIVE REPORT

The Washington State Legislature is scheduled to adjourn on April 23–Legislative Day 105.

As is typical, the legislature is poised to provide some, but not all, of what retirees have requested.

Plan 1 retirees are well-positioned for a COLA this summer, but legislators are insistent on capping it at 3%. Two technical bills to improve Plans 2 and 3 look like they'll pass. Other legislation to improve hearing aid coverage, prescription drug coverage, and dental benefits is currently up in the air.

All signs point to the legislature passing a 3% Plan 1 COLA capped at \$110 per month. WSSRA is advocating for extending this to provide a multi-year COLA to provide more certainty for retirees.

The House of Representatives passed House Bills 1008 and 1056. House Bill 1008 improves TRS/PERS/SERS 2 retiree health insurance options to match what is available for TRS/PERS/SERS 3 members. House Bill 1056 changes retirement rules so that all retirees may work a minimum of 867 hours per year in retirement without losing pension benefits. WSSRA is now advocating for Senate passage of both bills.

WSSRA is also supporting retiree dental legislation this year. Some of our members are experiencing sticker shock at out-of-network billing for hygienist services provided in long-term-care and memory care facilities. WSSRA is supporting efforts to expand dental services to accommodate our members living in facilities. It remains to be seen if this legislation will pass.

This is the last push. Thanks to everyone who contacted their legislators this session. If you're willing, it is not too late for one final round of lobbying on the issues you care about.

HEALTH CARE UPDATES ~ 2023

GOOD NEWS—under Medicare Part D:

*The price of insulin will be capped at \$35 a month. *Vaccines approved for adults by ACIP (Advisory Committee on Immunization Practices) will be free. If you've been putting off getting the shingles shots because of the expense, they are now free. This also applies to any COVID shots or future boosters.

*In 2024 there will be no out of pocket costs when one hits the catastrophic phase of the drug benefit.

INFLATION REDUCTION ACT: In 2023 drugproducing companies will be penalized if they raise their prices more than the rate of inflation. The penalty will be the amount the price was raised above inflation multiplied by what Medicare paid for the sales. They will have 30 days to pay Medicare. If not, they will pay a penalty of 125% of the rebate they owe.

BAD NEWS

*After May 11 when the public health emergency ends, OTC COVID tests will no longer be covered. Those who have private insurance or Medicare Advantage Plans may still have some coverage. Free tests may also still be found at free clinics, community health centers, public health departments, libraries, or other local organizations, or by mail through the USPS while supplies last.

*Medicare beneficiaries may have a cost share for COVID treatments such as Paxlovid. Any treatments the federal government purchased will still be free depending on the availability of the supply. Lab and antigen tests ordered by a physician or other health care provider will still be covered.

MORE NEWS: Washingtonians will still be able to order free COVID-19 home test kits from the Say Yes COVID Test website. However, starting March 13 eligibility is based on Washington communities that are most in need. Check www.sayyescovidhometest.org to see if you are eligible for 5 test kits delivered monthly to your home.
